

## Conditions of Entry and Competition Rules

1. These Conditions of Entry and Competition Rules apply to the *Niue Tourism* promotion with Newstalk ZB to be held between 13<sup>th</sup> July 2023 and ending on 23<sup>rd</sup> July 2023. Newstalk ZB (a Station of NZME) will conduct the promotion. New Zealand Media and Entertainment (NZME) reserves the right to add and/or delete participating stations at any time.
2. Entry into the promotion is deemed acceptance of these Conditions of Entry and Competition Rules. NZME reserves the right to exclude any person from the contest on the grounds of criminal record.
3. How to enter: Listeners are invited to register their details on the competition page at [newstalkzb.co.nz/win](http://newstalkzb.co.nz/win) to qualify for the prize draw to win a trip for two to Niue including flights, seven-nights' accommodation and excursions. Entries close 11.59pm Sunday 23<sup>rd</sup> July 2023 with the winner drawn at random on Monday 24<sup>th</sup> July 2023. Winner will be contacted by text and phone call.
4. The prize will consist of:
  - Two return economy flights from Auckland to Niue (flying Air New Zealand).
  - Seven-nights' accommodation for two in a deluxe room at the Scenic Matavai Resort, Niue, including daily breakfast for two, arrival drink and local food platter on arrival.
  - One-days' fishing charter (weather permitting) for two on, and in the waters surrounding the island of Niue with an operator selected by Niue Tourism.
  - Seven-day vehicle rental (excluding fuel).
  - One island tour for two (operator to be advised).
  - One land-based tour for two (operator to be advised).
  - \$500 voucher towards a Niue Blue experience of the winners' choosing.
  - **\$NZ1,500** cash to cover transfers/meals/insurance etc. (NZME to transfer cash directly to the winner's bank account)

Additional travel expenses, including but not limited to additional meals, excursions, pre or post 'prize' accommodation, transfers, items of a personal nature, in-room charges and all other ancillary costs are not included.
